授業の目標 (Course Objectives)

The main objectives of this course are (1) to become familiar with legal terms in English and (2) to improve skills of reading English articles.

授業の内容 (Course Contents)

This is a seminar-type course provided to build up students' vocabulary of English legal terms and improve their skills of reading English articles. The course will deal with 6 legal topics and two classes will be spent for each topic.

The topics will cover a wide range of legal issues so that students can become familiar with various legal terms. The topic will include Constitutional Law issues (e.g. restriction of freedom, dual surnames), Private Law issues (e.g. termination of contract, family law issues), Criminal Procedure Law (e.g. problems of Japanese criminal procedures), and Contemporary issues (e.g. AI). Topics and reading materials will be designated at the Introduction class.

Students will be expected to read 2 or 3 English materials (mainly, news reports) for each topic. At the first class for each topic, an interactive lecture will be provided to understand the topic and relevant legal terms by closely reading the materials. Based on that, students will discuss the topic at the Second class as an exercise of using the legal terms and expressing their views in English.
